This is a summary of the annual report of the The Reinalt-Thomas Corporation D/B/A Discount Tire / America's Tire / Discount Tire Direct Flexible Benefits Plan, EIN 38-1889682, Plan No. 501, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Reinalt-Thomas Corporation has committed itself to pay certain self-insured Medical and Dental claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Metropolitan Life Insurance Company, CuraLinc, LLC, D.B.A. CuraLinc Healthcare, and Life Insurance Company Of North America to pay Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$10,571,543.
