To help you and your store prepare, we've outlined the activities that should be completed leading up to your go-live.

Your primary focus for this week should be to complete the Buddy Store Visits.

1 Keep the following in mind when scheduling:

- This is AOR-AOR training. Your employees should be assigned to their respective AOR at the Buddy Store.
- Do not exceed more than two employees visiting the Buddy Store on the same day.
- Your Buddy Store will not be sending an employee to your store to cover during your visits, so please schedule accordingly.
- While you have been assigned a specific Buddy store, you may schedule visits with another Buddy store on the list depending on availability and proximity.
- DTU Learning System training is to be completed at your Buddy Store not beforehand.

| | NOTE: If an employee has worked in a Vision store within the last 60 days and is currently in an activation store, they are only required to complete the DTU Learning System training (ultimately at the discretion of the Store Manager). For employees who worked in a Vision store more than 60 days ago, they are required to complete both the DTU Learning System training and the Buddy Store visits. | | | | | | | |

| 2 | Trainee at GR10 Store | Attend scheduled Buddy Store Visit | 11/13 | 12/6 | <u>Trainer Assessment – Paper</u> | | | |
| | All Full-Time employees are expected to perform a full day in the Buddy Store. The day starts with the Trainee completing the Vision Learning Path training followed by Model, Teach, Coach hands-on experience alongside the assigned Trainer. | | | | | | | |
| 3 | Senior and Marketing | Review the latest list of Aged Layaways (six months and older) on the Final Cutover Activities tab and begin clearing them out. These MUST be cleared out from the POS no later than EOD Wednesday, December 3 to go live with the Vision POS. | 11/17 | 12/3 | Layaway and Gift Certificates Transition QRG Open Layaway List | | | |
