

SUMMARY ANNUAL REPORT

For THE TIRE RACK, INC. SECTION 125 PLAN

This is a summary of the annual report of the THE TIRE RACK, INC. SECTION 125 PLAN, EIN 35-1299716, Plan No. 501, for period 08/01/2022 through 07/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

THE TIRE RACK, INC. has committed itself to pay certain self-insured Medical claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with CURALINC HEALTHCARE, VISION SERVICE PLAN, DELTA DENTAL OF INDIANA, and THE LINCOLN NATIONAL LIFE INSURANCE COMPANY to pay Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 07/31/2023 were \$882,722.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 07/31/2023, the premiums paid under such "experience-rated" contracts were \$476,361 and the total of all benefit claims paid under these contracts during the plan year was \$461,064.
