Potential Health Effects

6. ACCIDENTAL RELEASE MEASURES

Small Spill:

Absorb liquid on vermiculite, floor absorbent or other absorbent material.

Large Spill:

Eliminate all ignition sources (flares, flames including pilot lights, electrical sparks). Persons not wearing protective equipment should be excluded from area of spill until clean up has been completed. Stop spill at source. Prevent from entering drains, sewers, streams or other bodies of water. Prevent from spreading. If runoff occurs, notify authorities as required. 7. HANDLING AND STORAGE

Handling:
