SECTION 4. FIRST AID MEASURES

Ingestion: If swallowed, **do not induce** vomiting. For advice, contact a Poisons Information

Skin: Remove contaminated clothing and wash affected areas with plenty of water. If

SECTION 5. FIRE FIGHTING MEASURES

Suitable extinguishing media: Use foam, dry chemical or carbon dioxide.
